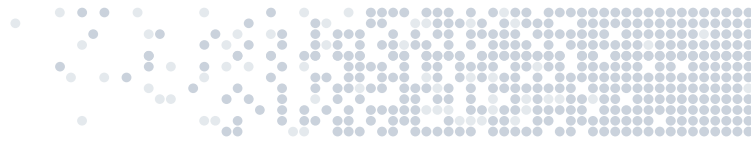

## BACKGROUND

- Australian Technical and Management College was first registered as a VET and CRICOS provider in September 2008
- The CEO and Managing Director of the RTO is Dr Manish Malhotra.
- The organisation’s target market is overseas students enrolled into Higher Education courses. The organisation delivers these courses on behalf of three Higher Education providers and has agreements with, Charles Darwin, Sunshine Coast and Federation Universities, and at the time of audit had 2100 overseas students enrolled in these courses.
- The provider is proposing to offer the Certificate III & IV Commercial Cookery and the Diploma of Hospitality Management to overseas students as a pathway to the Bachelor of Hospitality Management course at Sunshine Coast University and the provider has also applied for state government funding for these courses.
- The provider at the time of audit had 60 international students enrolled into VET courses and 10 domestic students enrolled into the *CHC50113 Diploma of Early Childhood Education*. The organisation also delivers ELICOS courses to students.
- The provider is proposing to train and assess the learners in the courses, Certificate III & IV Commercial Cookery and the Diploma of Hospitality Management from a commercial kitchen at 17-21 Buckhurst Street, South Melbourne.

The registered provider did not demonstrate with evidence it had adequate resource including facilities, equipment, learning and library resources and premises as required by the quality assurance framework applying to the course being Clause 1.3 (d) of the Standards for NVR Registered Training Organisations (RTOs) 2015, specifically:

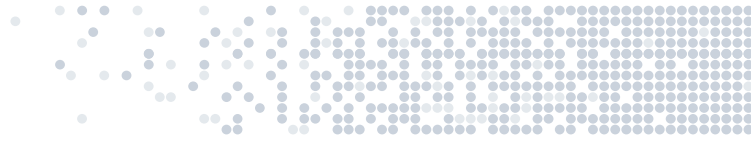
- The evidence did not demonstrate how the registered provider could guarantee access to the shared kitchen facilities at 17-21 Buckhurst Street, South Melbourne, VIC, 3205 for all times it would be in use, and;
- The license agreement for the commercial kitchen at 17-21 Buckhurst Street, South Melbourne, VIC, 3205, has not been signed by the provider on pg.10 of the aforementioned document, and it is unclear how the provider could guarantee access to the site for all times it would be used, and;
- The evidence did not demonstrate how the one bay as referenced in the kitchen license agreement for 17-21 Buckhurst Street, South Melbourne, VIC, 3205, could accommodate and support the number of learners proposed (420) undertaking training and assessment, and;
- The evidence did not demonstrate where skills must be demonstrated in an operational commercial kitchen, such as a training kitchen servicing customers in a simulated industry environment, how the commercial kitchen at 17-21 Buckhurst Street, South Melbourne, VIC, 3205 could accommodate and support the number of proposed learners (420).

***In order to become compliant, the organisation is required to:***

- Provide evidence to demonstrate the registered provider has the education resources including facilities, equipment, learning and library resources and premises as required by the quality assurance framework applying to the course.
