## **APPENDIX 1: OTHER IT QUALIFICATION CONSIDERATIONS**

- PYear applicants are required to have completed a Bachelor or higher degree in an IT Major from an Australian tertiary
  institution. ICT minors do not satisfy PYear entry requirements. In accordance with ACS' Migration Skills Assessment
  Guidelines, the determination of an eligible ICT major is based on the following assessable criteria:
  - A standard 3-year Bachelor level qualification is deemed as having a major in computing if **at least 33%** of the qualification is ICT.
  - A post graduate qualification [. . .] that <u>does not</u> require a Bachelor with an ICT major for entry is deemed as having a major in computing if **at least 50%** of the qualification is ICT. An Australian postgraduate degree with only 12 subjects requires **at least 67%** ICT content.
  - A post graduate qualification (Graduate Diploma, Masters or Doctoral qualification) that <u>does</u> require at least a Bachelor qualification with a major in ICT for entry into the course, must have ICT content of **at least 33%**, all of which must be at post graduate level.
  - For more details regarding ICT Major criteria, see <u>ACS Skills Assessment Guidelines for Applicants</u> or refer to further support regarding vetting qualifications below.
- Applicants must demonstrate that their Australian qualification in an IT Major is closely related to their future nominated occupation (ANZSCO). Per ACS Skills Assessment Guidelines for Applicants, at least 65% of the ICT content must be closely related to the nominated occupation. <u>Applicants will be required to provide ATMC PY with their nominated occupation (ANZSCO)</u> at the time of the Admission/Enrolment process.
- A list of Eligible Skilled Occupations (and assigned ANZSCO code) is available in the ANZSCO Code Information document available on the <u>Migration Skills Assessment page on the ACS website</u>. The ANZSCO code information is to assist applicants in nominating an ICT occupation and contains examples of employment duties for each occupation.
- In cases where a degree or testamur is not yet awarded, the applicant must provide a certified official document from the accredited tertiary institution that clearly states the date the student met all the course requirements and became eligible to be awarded the qualification. At the earliest, PYear commencement must occur after the stated date.
- As with visa requirements, priority for enrolment should be given to those applicants who have completed a suitable Australian ICT degree within the last two years. However, other applicants who have attained an Australian ICT qualification may be accepted.
- Applicants must satisfy the Australian Study Requirement (ASR) for visa purposes, and this does not have to be solely completed within a student's Australian ICT qualification. Per DHA, "to meet the Australian study requirement you must have completed either:
  - $\circ$  a single eligible qualification that requires at least 2 academic years study, or
  - o more than 1 qualification that results in a total of at least 2 academic years study resulting in an eligible qualification
  - You must have completed your study in Australia, in a total of no less than 16 calendar months, while you held a visa authorising you to study." ACS Skills Assessment does not assess whether applicants meet the ASR requirement for immigration. This is determined by DHA. See <u>immi.homeaffairs.gov.au</u> for more details.
- It is strongly recommended that PYPs refer all applicants who approach the Professional Year in ICT with borderline ICT Courses such as Business Information Systems, Commerce, Multimedia, and Data Science where subjects may not "predominantly educate persons to be a professional in ICT", for ACS Skills Assessment prior to enrolment.

<sup>^</sup>These subjects are not needed for enrolment into the PY Program, but may be needed for a positive skills assessment depending on the ANZSCO code a participant will apply for PR.

### APPENDIX 3: ELTS CONVERSION TABLE FOR PY ENROLMENTS

- TOEFL iBT total score of at least 64, with at least 12 in listening, 13 in reading, 18 in speaking, and 21 in writing.
- CAE overall score of at least 169 with nothing below 169 in each of the four test components
- OET a score of at least "B" (Pass) in each of the four test components
- PTE overall score of at least 50 with no bands below 50 in each of the four components



#### **APPENDIX 4: SKILLS ASSESSMENT**

#### ACS

In most cases, graduates of the Professional Year will seek to apply for permanent residency and will be required to undertake an ACS Migration Skills Assessment (MSA). While ACS MSA is not an entry requirement for the PY Program, the directions below provide applicants an additional avenue to vet their Australian qualification prior to Professional Year, mitigating certain student risks and fees should a preliminary assessment be deemed unfavourable.

- 1. Visit ACS Migration Skills Assessment at <u>acs.org.au</u> to review the Guidelines for Applicants and prepare required
- documentation.
- 2. Commence an Online Application and select the Application Type: "Temporary Graduate 485".
- 3. Nominate the relevant ANZSCO code for your qualification and/or work experience and complete the application.
- 4. ACS will issue an ACS Results Letter stating the degree's IT Major suitability and relevance to the nominated ANZSCO code.

**NOTE:** The purpose of an ACS Skills Assessment is for migration purposes connected with the Department of Home Affairs. **The above assessment does NOT guarantee a suitable future skills assessment following the Professional Year**. This assessment serves to provide information if the IT Degree is a Major in IT and is closely related to an applicant's nominated ANZSCO code.

ACS Migration Skills Assessment is a separate division within ACS and not related to the Professional Year Program. Skills Assessment applications and outcomes are securely managed and assessed independent of ACS Education. #### APYP

As authorised assessing authorities, the Accounting bodies for the Program (CPA, IPA, CA ANZ), conduct skills assessments to ensure that your qualifications and experience match the required standard of the industry in your chosen country. These assessing authorities can determine if you meet the educational standard for your nominated occupations, alongside the corresponding codes from Australia and New Zealand Standard Classification of Occupations (**ANZSCO**).
